2024 MISGA Membership Application

The Maryland Interclub Senior Golf Association (MISGA) at The Links at Challedon is for senior golfers age 50 or more who are members in good standing at Challedon. For more information about Challedon’s Annual 5- and 7-day Membership, stop by or call the Pro Shop at 301-829-3000 ext. 10. In addition, Challedon has agreed to offer something called a Handicap Membership. For an annual fee of \$25, the player receives Handicap Service through Challedon and is deemed a member for MISGA purposes. Note that a Challedon Membership (either of the above types) is separate from a MISGA membership. The former is a necessary but not a sufficient condition for the latter.

The cost to join Challedon’s MISGA for 2024 will be \$25. This includes both State and Local MISGA dues. Our treasurer, Ed Driscoll, may be able to answer any questions you have. Payment details are given at the end.

To ensure fair and equitable play in any MISGA event, all members must have and maintain a valid USGA handicap. To do that, all rounds played during the *active* season **must be posted** in the Maryland State Golf Association (MSGGA) handicap system (GHIN). Refer to the LAC MISGA [web site](#) for details. Note that the definition of *active season* varies from State to State.

To fully appreciate and enjoy the experience that MISGA offers, taking part in the various events that are scheduled for the coming season is key. To help encourage that participation, as well as support our two major Home Events (2-Day Club Championship and Season Finale/Party), we are **requiring a minimum participation in at least 6 Home Events** in order to be eligible to compete in the Two-Day Club Championship and participate in the Season Finale/Party. A Home Event can be either a Home Mixer or a Regular Play. Exceptions to this rule must be approved by the Executive Committee.

Members are required to be on time for all mixers they sign up to attend. **You are also responsible for notifying the host club as soon as possible when you have reason to cancel.** Some clubs are threatening to charge for a no-show (signed up to play, but does not show and fails to call the host club pro shop prior to one hour before tee-time). Other clubs have indicated they plan to assess a fee for missed meals because of no-shows. **If we are assessed either of these fees because you were the cause of the assessment, we will pass it on to you.** Please be considerate of the hosting club (including ours) by informing them of any change in your plans.
